Eligibility

Open to all artists over 18, original work only, no copies, giclees or class pieces. We will accept paintings, mixed media collage, sculpture, wood glass--none of which have been previously shown at the Guild.

Entry

Judged by slides or CDs. Two-dimensional work not to exceed 36" either way. Plexi-glass on all works over 18" x 24". All work must be for sale, with 25% commission to the Guild. Limit of 2 entries per person; only one will be accepted.

Acceptance

All work must be postmarked by April 1, 2010. Work must be done within the last 3 years. Sculpture must include a base no larger than 36" wide and 72" high.

Insurance

All work must be insured by the artists. The Guild will not be responsible for any damage, loss, or theft to works submitted. The OCAG reserves the right to reproduce entries for publicity.

Fees

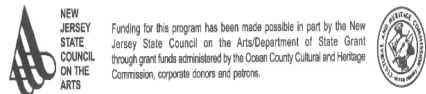
Guild members: \$20 for one entry; \$30 for two entries. Non-members: \$30 for one entry; \$50 for two entries.

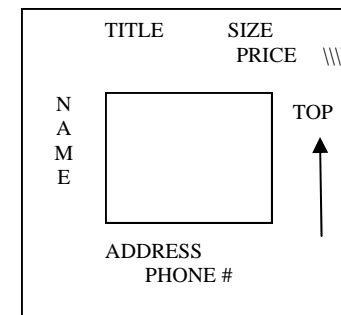
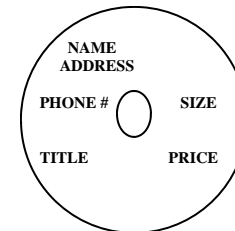
