

MEMBER SHOW AGREEMENT- Artist Copy

The Artist and the Ocean County Artist Guild hereby enter into the following agreement:

As used in this agreement the listed terms have the following meaning:

Artist: The individual submitting works for exhibition. **Gallery:** The Ocean County Artists Guild

Works: Original works of art including but not limited to, paintings (oil, acrylic or watercolor), mixed media, fiber art, sculpture, print including serigraphs, etchings, engravings, block prints, lithographs and monotypes, original digital art with archival inks and paper. Ceramic work will be original and not formed by a mold unless the mold was made by the artist. This term does not include reproductions in the form of photocopies or Giclee/Iris prints.

1. **The member artist agrees to pay \$5.00 for two pieces, however, NFS will be \$25 for two pieces.** This fee will be paid upon drop-off of art.

PAYMENT SCHEDULE: All payments will be made within 45 days of the end of the show.

2. The artist agrees that any work submitted is original and if mounted will be supported by wire and not saw tooth hangers. Gallery wrapped pieces will be accepted providing that they are at least 1 ½" thick with finished edges.
 3. For publicity purposes in connection with the exhibition, the artist will submit a digital image representing one of the works placed in the exhibit. The artist agrees to email these items, 90 days prior to the beginning of the exhibit.

 5. ***The parties to this contract agree that New Jersey Sales Tax will be collected by the gallery on all sales made during the exhibit and that the gallery will receive a 25% commission based on the sale's price.***
